# SURPRISE VALLEY ELECTRIFICATION CORP. RATE CHANGES – EFFECTIVE JANUARY 1, 2023

After much consideration and a Cost-of-Service Analysis by an outside firm, the Board of Directors at Surprise Valley Electric has deemed it necessary to adjust our rates in order to keep pace with manufacturing and operating costs.

Like many of you, SVEC is experiencing the effects of skyrocketing costs. We are facing unprecedented cost increases in wire, transformers, poles, fuel, overhead, and all costs associated with operating and maintaining a distribution electric cooperative. For example, transformer costs have risen approximately 147% on average from 2020 to 2022, while the cost of wire is up 91%, and copper costs have increased by about 116%.

In addition to increased maintenance and materials costs, SVEC has been actively engaged in efforts to reduce wildfire risk to our members and their property. These fire mitigation efforts represent a significant investment, but the changes in fuel load and the ongoing drought conditions have made this an unavoidable cost.

Due to these drivers, SVEC will implement a rate increase, effective January 1, 2023. Despite this rate increase, SVEC is still far below neighboring utilities, and we are well below the national average. Like all rural electric cooperatives, SVEC works on a non-profit, at-cost basis: we charge just what it costs to provide the service. As costs increase, we must also increase our rates accordingly.

Along with an energy charge increase of \$0.0035/KWh, there will be increases to monthly basic charges and outdoor lighting charges, some of which have not been changed for over 30 years. Prior to this change, residential, small commercial, and industrial basic charges were last updated in 2015, while irrigation basic charges have not been changed since 1985. Additionally, the rates for outdoor lighting have not changed since 2001.

The decision to increase rates is never an easy one to make, and we understand how it affects our members. Therefore, we at SVEC thank you for your ongoing support and trust that these changes will help us continue providing you with safe, reliable service.
